7 **A Resolution authorizing the County Executive to participate with the Village of Mogadore**
8 **in applying for Ohio Public Works Commission funding for the Prospect Street**
9 **Reconstruction Project, located in the Village of Mogadore, in County Council District 8,**
10 **with the County of Summit's share of the cost of the project estimated to be \$80,000.00,**
11 **and to execute any necessary agreements and other documents for the purposes of this**
12 **project, for the Executive's Department of Environmental Services, and declaring an**
13 **emergency.**

14
15 WHEREAS, the State Capital Improvements Program provides financial assistance to
16 political subdivisions for capital improvements to public infrastructure; and

17
18 WHEREAS, the improvements to the public infrastructure under the Prospect Street
19 Reconstruction Project ("Project") will include the rehabilitation of approximately 3,715 feet of
20 8" and 10" sanitary sewer by lining and/or replacement, with a total estimated cost of
21 construction for the lining and/or replacement of \$160,000.00; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County to participate in the Project, and to
25 authorize the execution of any necessary agreements and associated documents;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

30 SECTION 1

31
32 The County Executive is hereby authorized to participate in applying to the Ohio Public
33 Works Commission for funding assistance with the Village of Mogadore for the purpose of
34 constructing the Prospect Street Reconstruction Project.

36 SECTION 2

38 The terms of said application and associated documents shall maximize the requested
39 amount of State Issue 1 Funds, with the remainder of the cost of the improvements to be borne
40 by the City of Mogadore and the County of Summit through Department of Environmental
41 Services CIP funding, with the County's share being approximately \$80,000.00.

45 The Clerk of Council is instructed to provide two certified copies of this Resolution to the
46 Department of Environmental Services, for submission to the Ohio Public Works Commission
47 with said funding application.

7 welfare of the citizens of the County of Summit, and for the further reason that it will allow the
8 County to obtain grant funds for an immediately needed improvement in the Village of
9 Mogadore.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and any of its committees that resulted in such formal action, were

23 121.22 of the Ohio Revised Code.
