A Resolution authorizing the County Executive to participate with the Village of Mogadore in applying for Ohio Public Works Commission funding for the Prospect Street Reconstruction Project, located in the Village of Mogadore, in County Council District 8, with the County of Summit's share of the cost of the project estimated to be \$80,000.00, and to execute any necessary agreements and other documents for the purposes of this project, for the Executive's Department of Environmental Services, and declaring an emergency.

WHEREAS, the State Capital Improvements Program provides financial assistance to political subdivisions for capital improvements to public infrastructure; and

WHEREAS, the improvements to the public infrastructure under the Prospect Street Reconstruction Project ("Project") will include the rehabilitation of approximately 3,715 feet of 8" and 10" sanitary sewer by lining and/or replacement, with a total estimated cost of construction for the lining and/or replacement of \$160,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to participate in the Project, and to authorize the execution of any necessary agreements and associated documents;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

The County Executive is hereby authorized to participate in applying to the Ohio Public Works Commission for funding assistance with the Village of Mogadore for the purpose of constructing the Prospect Street Reconstruction Project.

SECTION 2

The terms of said application and associated documents shall maximize the requested amount of State Issue 1 Funds, with the remainder of the cost of the improvements to be borne by the City of Mogadore and the County of Summit through Department of Environmental Services CIP funding, with the County's share being approximately \$80,000.00.

SECTION 3

The Clerk of Council is instructed to provide two certified copies of this Resolution to the Department of Environmental Services, for submission to the Ohio Public Works Commission with said funding application.
