A Resolution authorizing the County Executive to execute a subgrant agreement with the Ohio Department of Job and Family Services for grants received by the County Executive's Department of Job and Family Services during State Fiscal Years 2014-2015 (7/1/13 through 6/30/15), for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08, that the Ohio Department of Job and Family Services may only make grants to counties through subgrant agreements as described in that Section; and

WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio Department of Job and Family Services developed a standard subgrant agreement to be executed by the Executive or commissioners of each county prior to receiving Department of Job and Family Services grant funds; and

WHEREAS, the County of Summit Department of Job and Family Services has received from the Ohio Department of Job and Family Services the standard subgrant agreement for State Fiscal Years ("SFY") 2014-2015 (7/1/13 through 6/30/15) that sets forth the rights and responsibilities of both the Ohio Department of Job and Family Services and the County Executive's Department of Job and Family Services in relation to any grant that is awarded for SFY 2014-2015; and

WHEREAS, the County of Summit Department of Job and Family Services anticipates receiving grant funds from the Ohio Department of Job and Family Services for SFY 2014-2015; and

WHEREAS, this Council has determined by reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute said subgrant agreement for SFY 2014-2015.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
