7 **A Resolution authorizing the County Executive to execute all documents necessary to**  
8 **accept, and appropriating federal Temporary Assistance to Needy Families Summer Youth**  
9 **Employment Program grant funds from the Summit County Department of Job and**  
10 **Family Services, in an amount not to exceed \$112,000.00, for Youth Employment for**  
11 **Success 2013 summer youth programs, being the Eligibility Program, for the Executive's**  
12 **Department of Communications, and declaring an emergency.**

14 WHEREAS, the Executive's Department of Job and Family Services ("DJFS") has been  
15 awarded Temporary Assistance to Needy Families ("TANF") funds from the Ohio Department  
16 of Job and Family Services, which have been appropriated to a Summer Youth Employment  
17 Program in Resolution No. 2013-182; and

18  
19 WHEREAS, DJFS has awarded \$18,000.00 of the TANF funds to the Executive's  
20 Department of Communications' Youth Employment for Success ("YES") for a 2013 Summer  
21 Youth Eligibility Determination Program, authorized in Board of Control Directive No. 088-13;  
22 and

24 WHEREAS, DJFS has awarded \$94,000.00 of the TANF funds to the Executive's  
25 Department of Communications' YES for a 2013 Summer Youth Employment Program,  
26 authorized by this Council by Resolution No. 2013-183; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 execute all documents necessary to accept and to appropriate the aforementioned funds in the  
31 total amounts of \$18,000.00 and \$94,000.00, for a grand total of \$112,000.00, with no local cash  
32 match requirement;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
