7 **A Resolution authorizing the Executive to execute a subgrant agreement with the Ohio**
8 **Department of Job and Family Services for the receipt of Title IV-E funds by the County of**
9 **Summit Juvenile Court, for the period 7/1/13 to 6/30/15, for the County of Summit Juvenile**
10 **Court, and declaring an emergency.**

12 WHEREAS, the County of Summit Juvenile Court is a subrecipient and subgrantee of
13 funds to administer programs under Title IV-E of the Social Security Act (Title IV-E funds),
14 with the State of Ohio serving as the grantee and recipient of said funds from the federal
15 government; and

17 WHEREAS, as a condition of the County of Summit Juvenile Court receiving Title IV-E
18 funds, the State of Ohio has requested that the County enter into a subgrant agreement with the
19 Ohio Department of Job and Family Services, setting forth the rights and responsibilities of each
20 party as they pertain to the receipt of Title IV-E funds, for the period 7/1/13 to 6/30/15; and

22 WHEREAS, the County of Summit enters into similar subgrant agreements for the
23 Executive's Department of Job and Family Services and Child Support Enforcement Agency;

26 WHEREAS, this Council finds and determines after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County to authorize the Executive to execute the
28 subgrant agreement;

30 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
31 State of Ohio, that:

35 The County Executive is hereby authorized to execute a subgrant agreement with the
36 Ohio Department of Job and Family Services for the receipt of Title IV-E funds by the County of
37 Summit Juvenile Court for the period 7/1/13 to 6/30/15.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the citizens of the County of Summit and for the further reason of immediately
43 authorizing the execution of the subgrant agreement to ensure timely receipt of said Title IV-E
44 funds.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
