8 **service contract with Courtview Justice Solutions, Inc., for software support, maintenance,**
9 **upgrades, training, licenses and migration of the Court of Common Pleas – Probate**
10 **Division’s case management system and eAccess software, maintenance and support, with**
11 **two one-year renewal options, approved by the IT Board 4/23/13, as Best Practical Source,**
12 **in an amount not to exceed \$99,451.00 \$166,676.00, for the Court of Common Pleas –**
13 **Probate Division, and declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting held May 1, 2013, awarded a
16 professional service contract with Courtview Justice Solutions, Inc., for software support,
17 maintenance, upgrades, training and migration of the Court of Common Pleas – Probate
18 Division’s case management system, in an amount not to exceed \$99,451.00, with two one-year
19 renewal options, approved by the IT Board April 23, 2013, as Best Practical Source, subject to
20 confirmation by County Council; and

22 WHEREAS, the Board of Control, at its meeting held May 8, 2013, awarded a
23 professional service contract with Courtview Justice Solutions, Inc. for upgrade services for the
24 Court of Common Pleas – Probate Division’s case management system, in an amount not to
25 exceed \$16,547.00, approved by the IT Board April 23, 2013; and

27 WHEREAS, the Board of Control, at its meeting held May 15, 2013, awarded a
28 professional service contract with Courtview Justice Solutions, Inc. for migration services for the
29 Court of Common Pleas – Probate Division’s case management system in an amount not to
30 exceed \$10,750.00, approved by the IT Board April 23, 2013; and

32 WHEREAS, the Board of Control, at its meeting held May 29, 2013, awarded a
33 professional service contract with Courtview Justice Solutions, Inc. for eAccess and case
34 management software, maintenance and support for the Court of Common Pleas – Probate
35 Division, in an amount not to exceed \$39,928.00, approved by the IT Board May 28, 2013; and

37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
38 that the contract is necessary and in the best interest of the County of Summit;
