7 **An amended Resolution reappropriating funds for the State Fiscal Year 2013 Community**  
8 **Corrections Act grant, for the period ending ~~7/31/13~~ 6/30/13, in the amount of \$16,000.00,**  
9 **for the Executive's Department of Law, Insurance and Risk Management - Division of**  
10 **Public Safety, and declaring an emergency.**

12 WHEREAS, pursuant Resolution No. 2012-205, County Council authorized the County  
13 Executive to accept and appropriate a 407 grant for State Fiscal Year 2013 from the State of  
14 Ohio Department of Rehabilitation and Correction ("ODRC"), through the Community  
15 Corrections Act ("CCA"), in the amount of \$1,239,107.00, with no local cash match  
16 requirement, for community corrections programs to be operated by the Adult Probation  
17 Department and Oriana House, Inc., for the period 7/1/12 through 6/30/13, and

18  
19 WHEREAS, Oriana House, Inc., has determined that its operating budget is less than  
20 originally anticipated; and

21  
22 WHEREAS, it is necessary to reappropriate funds in the amount of \$16,000.00 to  
23 reimburse costs associated with the County's Adult Probation Department; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to reappropriate the CCA 407  
27 grant funds in the amount of \$16,000.00;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

16 121.22 of the Ohio Revised Code.


