WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's overburdened juvenile justice system and allows local courts to target specific areas to help divert youth from being institutionalized; and

WHEREAS, the Court of Common Pleas – Juvenile Division has been awarded a State Fiscal Year ("SFY") 2014 RECLAIM Ohio Grant (Juvenile Delinquent Care and Custody) from the Ohio Department of Youth Services, which has estimated the annual award of \$4,346,068.63, for the period 7/1/13 to 6/30/14; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from the Ohio Department of Youth Services, and to appropriate grant funds;
