RESOLUTION NO. 2013-281

A Resolution authorizing the County Executive to pay an amount not to exceed \$75,000.00, representing the County's self-insured retention, to Houston Casualty Company, the County's liability insurer, toward the costs of legal representation and services on behalf of the County and Houston Casualty Company, the County's liability insurer, in a wrongful death lawsuit, Watts v. Summit County, et al., Case No. 5:13-cv-00549-BYP, before Judge Benita Y. Pearson in the United States District Court for the Northern District of Ohio, for the Executive and the Sheriff, and declaring an emergency.

WHEREAS, Donna Watts has filed a wrongful death lawsuit, Watts v. Summit County, et al., Case No. 5:13-cv-00549-BYP, before Judge Benita Y. Pearson in the United States District Court for the Northern District of Ohio, against the County of Summit, the County Sheriff, several Sheriff's Deputies, Advanced Correctional Healthcare, Inc. and several employees of Advanced Correctional Healthcare, Inc. as a result of the death of James Watts III at the County Jail (the "lawsuit"); and

WHEREAS, the County's liability insurer, Houston Casualty Company, has agreed to defend the County and has retained legal counsel, Mazanec, Raskin, Ryder & Co., L.P.A., to provide legal representation and services on behalf of the County and Houston Casualty Company in the lawsuit;

WHEREAS, under the terms of its insurance contract with Houston Casualty Company, the County has a \$75,000.00 self-insured retention on a claims made basis; and

WHEREAS, in order to have Mazanec, Raskin, Ryder & Co., L.P.A. provide legal representation and services on behalf of the County and Houston Casualty Company in the lawsuit, the County is required to pay the first \$75,000.00 of costs, representing its self-insured retention; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit the County Executive to pay an amount not to exceed \$75,000.00, to Houston Casualty Company toward the costs of legal representation and services on behalf of the County and Houston Casualty Company in the lawsuit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to pay an amount not to exceed \$75,000.00, representing the County's self-insured retention, to Houston Casualty Company, the County's liability insurer, toward the costs of legal representation and services on behalf of the County and Houston Casualty Company, the County's liability insurer, in a wrongful death lawsuit, Watts v. Summit County, et al., Case No. 5:13-cv-00549-BYP, before Judge Benita Y. Pearson in the United States District Court for the Northern District of Ohio (the "lawsuit").
