A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of Summit, ratifying purchases by the County Executive in calendar year 2013 from Wolff Brothers Supply, Inc. for replacement parts and materials for numerous operations within the County Executive's Office, in the aggregate amount of \$32,040.94, and authorizing additional purchases in an amount not to exceed \$94,000.00, for a total aggregate amount not to exceed \$126,040.94, for calendar year 2013, for the Executive's Departments of Environmental Services, Administrative Services and Job and Family Services, and declaring an emergency.

WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar year, where no additional competitive quotes or bids have been taken, shall be made only upon authorization of County Council; and

WHEREAS, the Department of Finance and Budget and the Board of Control have previously approved purchases by the County Executive in calendar year 2013 in aggregate totaling \$32,040.94 for the Departments of Environmental Services, Administrative Services and Job and Family Services with Wolff Brothers Supply, Inc. for replacement parts and materials for numerous operations within the County Executive's Office; and

WHEREAS, the Departments of Environmental Services, Administrative Services and Job and Family Services anticipate that the County Executive will make additional purchases in calendar year 2013 from Wolff Brothers Supply, Inc. for replacement parts and materials in an additional amount not to exceed \$94,000.00, for a total aggregate amount not to exceed \$126,040.94 in calendar year 2013; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to ratify purchases by the County Executive in calendar year 2013 from Wolff Brothers Supply, Inc. for replacement parts and materials for numerous operations within the County Executive's Office in the aggregate amount of \$32,040.94, and to authorize additional purchases in an amount not to exceed \$94,000.00, for a total aggregate amount not to exceed \$126,040.94, for calendar year 2013.
