7 A Resolution authorizing the County Executive to execute any documents necessary to  
8 accept an award of federal funds in a Temporary Assistance to Needy Families Title XX  
9 grant, from the Executive's Department of Job and Family Services, for the Juvenile  
10 Court's Guardian Ad Litem services, for the period 7/1/13 through 9/30/13, in the amount  
11 of \$64,897.00, with no local cash match requirement, and appropriating the total of  
12 \$64,897.00 for expenditures through 9/30/13, for the Court of Common Pleas - Juvenile  
13 Division, and declaring an emergency.

15 WHEREAS, the County Executive's Department of Job and Family Services  
16 ("SCDJFS") has awarded a Temporary Assistance to Needy Families Title XX ("TANF-Title  
17 XX") grant of federal funds in the amount of \$64,897.00, with no local cash match requirement,  
18 to the Court of Common Pleas - Juvenile Division ("Juvenile Court") for Guardian Ad Litem  
19 services, for the period 7/1/13 through 9/30/13; and

21 WHEREAS, the Guardian Ad Litem is a party to Court proceedings with the role to  
22 provide investigation, assessment, recommendations, monitoring, and advocacy, in order to  
23 assist the Court in making decisions in the best interest of the children; and

25 WHEREAS, County Council previously passed Resolution No. 2013-282 confirming the  
26 award by the Board of Control of the intergovernmental agreement; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 execute any documents necessary to accept the award of the aforementioned grant from the  
31 SCDJFS, and to appropriate these grant funds;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

38 The County Executive is hereby authorized to execute any documents necessary to accept  
39 the award of a Temporary Assistance to Needy Families Title XX grant award from the Summit  
40 County Department of Job and Family Services ("SCDJFS"), for the period 7/1/13 through  
41 9/30/13, in the amount of \$64,897.00, with no local cash match requirement.
