A Resolution authorizing the County Executive to execute an amendment to the collective bargaining agreement between the International Union of Operating Engineers, Local 18, the Engineer, and the Executive, authorizing a zero percent (0%) salary increase for the second year of the agreement, from 4/1/13 through 3/31/14, and a one and one-half percent (1.5%) salary increase for the third year of the agreement, from 4/1/14 through 3/31/15, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, pursuant to Resolution No. 2012-188, this Council authorized the County Executive to execute a collective bargaining agreement between the International Union of Operating Engineers, Local 18, the Engineer and the Executive, for the period 4/1/12 through 3/31/15; and

WHEREAS, the aforementioned collective bargaining agreement provides for a wage reopener in the second and third year of the agreement, from 4/1/13 through 3/31/14 and from 4/1/14 through 3/31/15 respectively; and

WHEREAS, a recent fact-finding decision awarded the bargaining-unit employees in the Engineer's Office who are members of the American Federation of State, County and Municipal Employees, Local 1032 (Service and Maintenance Unit), a zero percent (0%) salary increase for the second year of the agreement, from 4/1/13 through 3/31/14, and a salary increase of one and one-half percent (1.5%) for the final year of the agreement, from 4/1/14 through 3/31/15; and

WHEREAS, for purposes of pay equity, it is necessary to authorize the Executive to execute an amendment to the collective bargaining agreement between the International Union of Operating Engineers, Local 18, the Engineer, and the Executive authorizing a zero percent (0%) salary increase for the second year of the agreement, from 4/1/13 through 3/31/14, and a one and one-half percent (1.5%) salary increase for the third year of the agreement, from 4/1/14 through 3/31/15; and

WHEREAS, the proposed amendment to the agreement with the International Union of Operating Engineers is consistent with the County's practice of patterned bargaining; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned amendment to the collective bargaining agreement;

NOW, THEREFORE BE IT RESOLVED by the Council of the County of Summit, State of Ohio that:

SECTION 1

The County Executive is hereby authorized to execute an amendment to the collective bargaining agreement between the International Union of Operating Engineers, Local 18, the Engineer, and the Executive authorizing a zero percent (0%) salary increase for the second year of the agreement, from 4/1/13 through 3/31/14, and a one and one-half percent (1.5%) salary increase for the third year of the agreement, from 4/1/14 through 3/31/15.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
