10 **Pleas – Juvenile Division, and declaring an emergency.**

12 WHEREAS, Resolution No. 2012-372 accepted and appropriated a Temporary
13 Assistance to Needy Families (“TANF”) grant award of federal funds in the amount of
14 \$340,000.00, with no local cash match requirement, from the County of Summit Department of
15 Job and Family Services (“SCDJFS”), for a Family Resource Center Program grant, for the
16 period 10/1/12 through 9/30/13; and

18 WHEREAS, the costs of the benefits were underestimated, and \$25,000.00 is available in
19 unused salary appropriations to be transferred to cover the deficit; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the adjustment of the appropriation of the aforementioned grant fund is necessary and in the
23 best interest of the County of Summit;


