7 **A Resolution authorizing the County Executive to execute a subgrant agreement, as a**
8 **representative of Workforce Investment Act (“WIA”) Local Area 2, with the Ohio**
9 **Department of Job and Family Services and the Medina County Department of Job and**
10 **Family Services, for WIA Local Area 2 grants received by the County of Summit**
11 **Department of Job and Family Services during State Fiscal Year (“SFY”) 2014 (7/1/13**
12 **through 6/30/14) and State Fiscal Year 2015 (7/1/14 through 6/30/15), for the Executive’s**
13 **Department of Job and Family Services, and declaring an emergency.**

15 WHEREAS, Section 5101.21 of the Ohio Revised Code provides, commencing 7/1/08,
16 that the Ohio Department of Job and Family Services may only make grants to counties through
17 subgrant agreements as described in that Section; and

18
19 WHEREAS, in conformance with Section 5101.21 of the Ohio Revised Code, the Ohio
20 Department of Job and Family Services developed a standard subgrant agreement to be executed
21 by the commissioners of each county prior to receiving Ohio Department of Job and Family
22 Services grant funds; and

24 WHEREAS, the County of Summit Department of Job and Family Services and the
25 Medina County Department of Job and Family Services have received from the Ohio
26 Department of Job and Family Services the standard subgrant agreement for SFY 2014 (7/1/13
27 through 6/30/14) and SFY 2015 (7/1/14 through 6/30/15) that sets forth the rights and
28 responsibilities of all parties in relation to any WIA grant that is awarded for WIA Local Area 2
29 for SFY 2014 and SFY 2015; and

31 WHEREAS, the County of Summit Department of Job and Family Services and the
32 Medina County Department of Job and Family Services anticipate receiving WIA grant funds for
33 WIA Local Area 2 from the Ohio Department of Job and Family Services for SFY 2014 and
34 SFY 2015; and

36 WHEREAS, this Council has determined by reviewing all pertinent information that it is
37 necessary and in the best interest of the County of Summit to authorize the County Executive to
38 execute said subgrant agreement for SFY 2014 and SFY 2015.

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The County Executive is hereby authorized to execute a subgrant agreement, as a
46 representative of Workforce Investment Act (“WIA”) Local Area 2, with the Ohio Department of
47 Job and Family Services and the Medina County Department of Job and Family Services for
48 Workforce Investment Act (“WIA”) Local Area 2 grants received by the County of Summit
49 Department of Job and Family Services during State Fiscal Year (“SFY”) 2014 (7/1/13 through
50 6/30/14) and State Fiscal Year 2015 (7/1/14 through 6/30/15). A copy of said subgrant
51 agreement is attached hereto as Exhibit A and incorporated herein by reference.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and
7 welfare of the citizens of the County of Summit, and for the further reason that it is necessary to
8 immediately execute said subgrant agreement so that the County of Summit Department of Job
9 and Family Services is eligible to be awarded WIA grant funds for WIA Local Area 2 from the
10 Ohio Department of Job and Family Services for SFY 2014 and SFY 2015.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and shall be in force at the earliest time provided by law.


