A Resolution increasing the 2013 Prosecutor’s Office Victims of Crime Act grant operating budget in the amount of \$1,000.00 and adjusting appropriations in the amount of \$5,500.00 for the fiscal year ending 12/31/13, for the County of Summit Prosecutor, and declaring an emergency.

WHEREAS, this Council previously adopted Resolutions No. 2012-385 and No. 2013-049, which approved and appropriated the 2013 operating budget for the Prosecutor’s Office Victims of Crime Act (“VOCA”) grant for the fiscal year ending 12/31/13; and

WHEREAS, due to a change in employee medical insurance election for 2013, a shortage exists within the Prosecutor’s VOCA grant employee benefits appropriations; and

WHEREAS, in order to provide adequate funding for employee benefits, it is necessary to increase the operating budget by \$1,000.00 and adjust appropriations by an additional \$5,500.00 and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned increase and adjustment of the existing appropriation is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:
