7 **An amended Resolution authorizing the County Executive to execute any documents**
8 **necessary to accept an award from the Summit County Department of Job and Family**
9 **Services Family Resource Center, as part of a funding collaborative, of a Federal Fiscal**
10 **Year 2014 Temporary Assistance to Needy Families grant, in the amount of \$340,000.00,**
11 **with no local cash match requirement, for the period 10/1/13 through 9/30/14, and**
12 **appropriating \$340,000.00, for the County of Summit Court of Common Pleas – Juvenile**
13 **Division, and declaring an emergency.**

14
15 WHEREAS, the County of Summit Court of Common Pleas – Juvenile Division has been
16 awarded a Temporary Assistance to Needy Families (“TANF”) grant, from the Executive’s
17 Department of Job and Family Services, for the funding of a local collaborative in providing
18 services to families, in the amount of \$340,000.00, with no local cash match requirement; and

20 WHEREAS, this funding is to provide case management to at risk youth and their
21 families who are involved in domestic violence disputes, are pregnant or parenting teens, are
22 teens at risk of dropping out of school or are returning from long term stays at the Ohio
23 Department of Youth Services, detention or other placements; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned TANF grant from
28 the Executive’s Department of Job and Family Services, and to appropriate these grant funds;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The County Executive is hereby authorized to execute any documents necessary to accept
36 an award from the Executive’s Department of Job and Family Services, as part of a funding
37 collaborative, of a Temporary Assistance to Needy Families (“TANF”) grant, in the amount of
38 \$340,000.00, with no local cash match requirement, for the period 10/1/13 through 9/30/14.

28 121.22 of the Ohio Revised Code.


