7 **A Resolution confirming the revised assessment for the South Main Street Improvements**
8 **Project – Pump Station and Gravity Sewer Q-940-1 and Moore Road Force Main Project**
9 **Q-940-2, in the total amount of \$259,649.12 as final and conclusive, and certifying the final**
10 **assessment of the Project, as listed in Exhibit A, to the Fiscal Officer to be placed on the tax**
11 **list and duplicate for collection in semi-annual installments over 20 years at no interest, in**
12 **the City of Green, in Council District 8, for the Executive’s Department of Environmental**
13 **Services, and declaring an emergency.**

15 WHEREAS, construction of the Project has been completed; and

16
17 WHEREAS, the Executive’s Department of Environmental Services has presented to this
18 Council a revised assessment for the Project in the total amount of \$259,649.12 based on the
19 tentative assessment previously approved by County Council in Resolution No. 2004-013-
20 Substitute and ratified by County Council in Resolution No. 2004-083; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to confirm the revised
24 assessment in the total amount of \$259,649.12, and that said amount should be final and
25 conclusive (“Final Assessment”); and

27 WHEREAS, in accordance with Section 6117.33 of the Ohio Revised Code, this Council
28 has determined that it is in the best interest of the County of Summit that the final assessment
29 amount of \$259,649.12 should be apportioned to the properties within the Project boundaries as
30 stated in Exhibit A, and certified to the Fiscal Officer to be placed on the tax list and duplicate
31 for collection in semi-annual installments over 20 years at no interest;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The revised assessment for the South Main Street Improvements Project – Pump Station
39 and Gravity Sewer Q-940-1 and Moore Road Force Main Project Q-940-2 (“Project”) in the
40 amount of \$259,649.12 is hereby confirmed by this Council, and said amount shall be final and
41 conclusive (“Final Assessment”).

45 The Final Assessment for the Project in the total amount of \$259,649.12 shall be
46 apportioned to the properties within the Project boundaries as stated in Exhibit A and certified to
47 the Fiscal Officer to be placed on the tax list and duplicate for collection in semi-annual
48 installments over 20 years at no interest.
