7 **A Resolution revising the assessments for the residents of Glencairn Forest Phase VII,**
8 **located in Richfield Township, in Council District 1, for drainage maintenance, for the**
9 **Engineer, and declaring an emergency.**

11 WHEREAS, by Resolution No. 2013-443, this Council will approve the plat for
12 Glencairn Forest Phase VII re-plat; and

13
14 WHEREAS, said plat includes a drainage maintenance assessment provision signed by
15 all owners of parcels located within said subdivision, with said provision applying to subsequent
16 owners of the same parcels; and

17
18 WHEREAS, assessments for drainage maintenance also are permitted by Sections
19 6137.02 and 6137.03 of the Ohio Revised Code; and

20
21 WHEREAS, the County Engineer seeks to revise a drainage maintenance fund for said
22 subdivision and to fully execute its powers and duties thereof; and

23
24 WHEREAS, the County Engineer has prepared a Revised Special Assessment
25 Worksheet, attached as Exhibit A, which apportions necessary charges for drainage maintenance
26 among the subdivision's benefited parcel owners; and

27
28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that revising the assessments for the residents of Glencairn Forest Phase VII, located in Richfield
30 Township, in Council District 1, for drainage maintenance, per attached Exhibit A, is necessary
31 and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

36 SECTION 1

38 A drainage maintenance fund for Glencairn Forest Phase VII, located in Richfield
39 Township, in Council District 1, is hereby revised.

41 SECTION 2

43 Owners of parcels within Glencairn Forest Phase VII re-plat of the Glencairn Forest
44 Phase VII subdivision shall be assessed for drainage maintenance per the attached Revised
45 Special Assessment Worksheet, attached as Exhibit A. Each assessment is proportional to the
46 estimated benefit to the respective parcel.

7 the attached assessments to the County Fiscal Officer for placement on the next succeeding tax
8 duplicate to be collected and paid.

12 This Resolution is hereby declared an emergency in the interest of the health, safety, and
13 welfare of the citizens of the County of Summit, and for the further reason to immediately fund
14 necessary drainage maintenance in the Glencairn Forest Phase VII subdivision in Richfield
15 Township.

19 Provided this Resolution receives the affirmative vote of eight members, it shall take
20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

26 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
27 deliberations of this Council and of any of its committees that resulted in such formal action,
