7 **A Resolution ratifying the County Executive's execution of a one-year policing contract**  
8 **with the Summit County Combined General Health District to provide one Sheriff's**  
9 **Deputy and one vehicle for community based policing, on a per unit basis, for Adult**  
10 **Protective Services, for the period 10/1/13 through 9/30/14, for which the District will pay**  
11 **the County the amount of \$135,000.00, and authorizing the Executive to execute an**  
12 **addendum to the policing contract to add an additional Sheriff's Deputy and vehicle during**  
13 **the term, for which the District will pay the County the additional amount of \$72,591.54,**  
14 **for a total amount of \$207,591.54, for the Sheriff, and declaring an emergency.**

15  
16 WHEREAS, this Council previously adopted Resolution No. 2013-123, which authorized  
17 the County Executive to execute a one-year policing contract with the Summit County Combined  
18 General Health District to provide one Sheriff's Deputy for community based policing, on a per  
19 unit basis, related to an Adult Protective Services Pilot Project, for the period 10/1/12 through  
20 9/30/13, with one option to renew for an additional one-year term, for a total amount of  
21 \$90,000.00; and

23 WHEREAS, this Council subsequently adopted Resolution No. 2013-337, which  
24 authorized the Executive to execute an amendment to the aforementioned policing contract to  
25 add one additional Sheriff's Deputy for a period of 10 weeks, for the period 7/22/13 through  
26 9/20/13, for an additional cost of \$20,000.00, for a new total amount of \$110,000.00; and

27  
28 WHEREAS, the Executive executed a new one-year policing contract with the Summit  
29 County Combined General Health District to provide one Sheriff's Deputy and one vehicle for  
30 community based policing, on a per unit basis, for Adult Protective Services, for the period  
31 10/1/13 through 9/30/14, in the amount of \$135,000.00; and

33 WHEREAS, it is necessary for this Council to ratify the Executive's execution of the  
34 aforementioned policing contract; and

35  
36 WHEREAS, the District has requested to add an additional Sheriff's Deputy and vehicle  
37 during the term, in an additional amount of \$72,591.54, for a total amount of \$207,591.54; and

38  
39 WHEREAS, it is necessary to authorize the Executive to execute an addendum to the  
40 aforementioned policing contract to add the additional Sheriff's Deputy and vehicle; and

41  
42 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
43 that it is necessary and in the best interest of the County of Summit to ratify the Executive's  
44 execution of the aforementioned one-year policing contract with the Summit County Combined  
45 General Health District and to authorize the Executive to execute an addendum to the policing  
46 contract to add the additional Sheriff's Deputy and vehicle, for the total amount of \$207,591.54;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

4 SECTION 1

5  
6 The County Executive's execution of a one-year policing contract with the Summit  
7 County Combined General Health District to provide one Sheriff's Deputy and one vehicle for  
8 community based policing, on a per unit basis, for Adult Protective Services, for the period  
9 10/1/13 through 9/30/14, in an amount of \$135,000.00, is hereby ratified.

11 SECTION 2

12  
13 The County Executive is hereby authorized to execute an addendum to the policing  
14 contract to add an additional Sheriff's Deputy and vehicle during the term, in an additional  
15 amount of \$72,591.54, for a total amount of \$207,591.54.

17 SECTION 3

19 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
20 welfare of the citizens of the County of Summit and for the further purpose of immediately  
21 providing necessary policing to Summit County Combined General Health District for Adult  
22 Protective Services effective 10/1/13.

24 SECTION 4

26 Provided this Resolution receives the affirmative vote of eight members, it shall take  
27 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
28 effect and be in force at the earliest time provided by law.

30 SECTION 5

32 It is found and determined that all formal actions of this Council concerning and relating  
33 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
34 deliberations of this Council and of any of its committees that resulted in such formal action,  
35 were in meetings open to the public, in compliance with all legal requirements, including Section  
36 121.22 of the Ohio Revised Code.
