A Resolution authorizing the County Executive to execute the renewal (first of two) of an agreement with Oriana House, Inc., for Adult Joint Drug Court programming, for the period 1/1/14 through 12/31/14, in an amount not to exceed \$293,687.00, funded by the Fiscal Year 2012 Substance Abuse and Mental Health Administration grant, for the Executive's Department of Law, Insurance and Risk Management – Division of Public Safety and declaring an emergency.

WHEREAS, the United States Department of Health and Human Services has awarded a Substance Abuse and Mental Health Administration ("SAMHSA") grant, in an amount not to exceed \$975,000.00, with no local cash match requirement, for the project period 9/30/12 through 9/29/15, to the County of Summit, for the operation of a Fiscal Year 2012 Joint Adult Drug Court program; and

WHEREAS, these grants are provided in annual installments of \$325,000.00 and subject to performance reviews; and

WHEREAS, SAMHSA has awarded the second installment of the grant, in an amount not to exceed \$325,000.00, with no local cash match requirement, for the period 9/30/13 through 9/29/14, to the County of Summit, for the operation of a Fiscal Year 2012 Joint Adult Drug Court program; and

WHEREAS, this Council previously adopted Resolution No. 2014-018, which authorized the County Executive to execute any documents necessary to accept the aforementioned grants and appropriated grant funds; and

WHEREAS, it is necessary for this Council to authorize the Executive to execute a renewal to the agreement with Oriana House, Inc., for Adult Joint Drug Court programming, for the period 1/1/14 through 12/31/14, in an amount not to exceed \$293,687.00, funded by the Fiscal Year 2012 SAMHSA grant; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned renewal.;
