7 **A Resolution appropriating funds for the County Sheriff in the amount of \$276,112.32 in**
8 **carryover balances in various grants for calendar year 2014, for the Sheriff, declaring an**
9 **emergency.**

11 WHEREAS, the County Sheriff has three grants which end 9/30/14 with carryover
12 balances from the Ohio Department of Public Safety/Ohio Traffic Safety Office, including
13 \$126,262.08 in the Operating a Vehicle Intoxicated task force grant, \$10,296.00 in the Law
14 Enforcement Liaison grant and \$73,294.68 in the High Visibility Enforcement Overtime grant;

17 WHEREAS, the County Sheriff also has a Drug Law Enforcement Fund grant with a
18 carryover balance of \$66,259.56 with an ending date of 1/31/14 from the Ohio Department of
19 Public Safety/Office of Criminal Justice; and

21 WHEREAS, it is necessary to appropriate these carryover funds from 2013 for 2014
22 operations; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that the aforementioned appropriations are necessary and in the best interest of the County of
26 Summit;
