7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a fiscal year 2014 Statewide Search and Rescue Water Grant from the Ohio**
9 **Emergency Management Agency, in the amount of \$4,375.00, with no local cash match**
10 **requirement, for the period 7/1/13 through 6/30/14, and appropriating these grant funds,**
11 **for the Executive’s Department of Law, Insurance and Risk Management – Division of**
12 **Public Safety/Emergency Management Agency, and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency (“OEMA”) has granted a fiscal
15 year 2014 Statewide Search and Rescue Water Grant to the Summit County Emergency
16 Management Agency (“SCEMA”) in the amount of \$4,375.00, with no local cash match
17 requirement, for the period 7/1/13 through 6/30/14; and

19 WHEREAS, the purpose of the grant is to help sustain the Region 5 water rescue
20 capabilities through the purchase of equipment, expendable materials and supplies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to authorize the County
24 Executive to execute any documents necessary to accept the award of the aforementioned grant
25 and to appropriate these grant funds;
