7 **A Resolution authorizing the County Executive to advertise for bids for the 2014 regional**
8 **pavement maintenance programs, for an estimated total cost not to exceed \$2,525,000.00,**
9 **for the Engineer, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

14 WHEREAS, the County Executive wishes to advertise for bids for the 2014 regional
15 pavement maintenance programs; and

17 WHEREAS, a copy of the project estimates are attached as Exhibit A; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that is necessary and in the best interest of the County of Summit to authorize the Executive to
21 advertise for bids for the 2014 regional pavement maintenance programs;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that;

26 SECTION 1

28 The County Executive is authorized to advertise for bids for the 2014 regional pavement
29 maintenance programs, per attached Exhibit A, for an estimated total cost not to exceed
30 \$2,525,000.00.

32 SECTION 2

34 This Resolution is declared an emergency in the interest of the health, safety, and welfare
35 of the citizens of the County of Summit, and for the further reason that it authorizes the
36 Executive to immediately advertise for bids for the County Engineer's 2014 regional pavement
37 maintenance programs which historically yields lower prices than those accepted later in the
38 year.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and any of its committees that resulted in such formal action, were
