7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award from the Ohio Department of Public Safety of a federally funded 2013**  
9 **Domestic Violence Court grant, for the period 1/1/14 through 12/31/14, in the amount of**  
10 **\$40,000.00, with a local cash match requirement of \$13,333.33, and appropriating the total**  
11 **of \$53,333.33 for expenditures in 2014, for the Court of Common Pleas – General Division,**  
12 **and declaring an emergency.**

13  
14 WHEREAS, the Ohio Department of Public Safety has awarded a federally funded 2013  
15 Domestic Violence Court grant to the Court of Common Pleas – General Division, for the period  
16 1/1/14 through 12/31/14, in the amount of \$40,000.00, with a local cash match requirement of  
17 \$13,333.33, to provide for the expenses of a probation officer; and

18  
19 WHEREAS, the Domestic Violence Court grant provides funding for payroll expenses of  
20 a probation officer who will oversee convicted domestic violence offenders and insures the  
21 attendance of these offenders in program sessions designed to reduce violent behaviors; and

22  
23 WHEREAS, the Domestic Violence Court grant requires a local cash match requirement  
24 in the amount of \$13,333.33, which will be provided by the Court’s General Fund and will help  
25 support staff benefits costs and program supply needs for the operation of this grant; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
29 execute any documents necessary to accept the award of the aforementioned grant from the Ohio  
30 Department of Public Safety, and to appropriate these grant funds;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept  
38 the award of a federally funded 2013 Domestic Violence Court grant from the Ohio Department  
39 of Public Safety, for the period 1/1/14 through 12/31/14, in the amount of \$40,000.00, with a  
40 \$13,333.33 local cash match requirement.

29 121.22 of the Ohio Revised Code.


