7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award by the Public Utilities Commission of Ohio of a 2014 training fund grant,**
9 **for the period 12/18/13 through 12/18/14, in the amount of \$22,497.00, with no local cash**
10 **match requirement, and appropriating the total of \$22,497.00 for training expenditures in**
11 **2014, for the Executive Department of Law, Insurance and Risk Management - Division of**
12 **Public Safety/ Emergency Management Agency, and declaring an emergency.**

14 WHEREAS, the Public Utilities Commission of Ohio (“PUCO”) has awarded a PUCO
15 training fund grant to the Executive’s Department of Law, Insurance and Risk Management –
16 Division of Public Safety/Emergency Management Agency (“EMA”), for the period 12/18/13
17 through 12/18/14, in the amount of \$22,497.00, with no local cash match requirement, to provide
18 for three EMA Special Operations Response Team (“SORT”) trainings; and

20 WHEREAS, the three trainings will be provided to fire service personnel for cargo tank
21 emergency response; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the award of the aforementioned grant from the
26 PUCO, and to appropriate these grant funds;

33 The County Executive is hereby authorized to execute any documents necessary to accept
34 the award of a Public Utilities Commission of Ohio (“PUCO”) training fund grant award from
