A Resolution authorizing the County Executive to execute a Real Estate Purchase Agreement with Habitat for Humanity of Summit County, Inc., for the sale of two vacant parcels of County real property (Parcel Nos. 62-01369 and 62-00284) located on Stanford Street and Buchtel Street respectively, in Twinsburg Township, in Council District 1, for \$1.00 each, for the purpose of constructing affordable housing for low and moderate income residents, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the County of Summit owns two vacant parcels of real property (Parcel Nos. 62-01369 and 62-00284) located on Stanford Street and Buchtel Street respectively, in Twinsburg Township, in Council District 1, which are capable of being developed as residential property; and

WHEREAS, Habitat for Humanity of Summit County, Inc. ("Habitat"), is a nonprofit developer with substantial experience in construction, renovation and rehabilitation of properties for low and moderate income Summit County residents; and

WHEREAS, Habitat has agreed to construct safe, sanitary, and affordable homes on the parcels for purchase by low and moderate income persons and the County has determined it to be in its best interest to develop the property in such a manner; and
