14 County DJFS") has been awarded Temporary Assistance to Needy Families ("TANF") funds
15 from the Ohio Department of Jobs and Family Services, in Resolution No. 2013-212; and

17 WHEREAS, Summit County DJFS has awarded \$25,000.00 of the TANF funds to the
18 County Executive's Department of Communications Youth Employment for Success ("YES")
19 for a 2014 Summer Youth Eligibility Determination Program, authorized in Board of Control
20 Directive 058-14; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County of Summit to appropriate the
24 aforementioned funds totaling \$25,000.00, with no local cash match requirement;
