A Resolution authorizing the County Executive to approve an enterprise zone agreement between the County of Summit, the City of Cuyahoga Falls, SGS Tool Company and Crooked River Realty LLC/Haag Investments, allowing tax incentives with the Cuyahoga Falls Enterprise Zone, in Council District 3, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the County of Summit created the Cuyahoga Falls Enterprise Zone to encourage job creation and economic development within the County; and

WHEREAS, SGS Tool Company has submitted an application to receive tax abatements through the Ohio Enterprise Zone Program to the City of Cuyahoga Falls; and

WHEREAS, the City of Cuyahoga Falls has entered into an enterprise zone agreement with SGS Tool Company to offer tax incentives for an eligible project within the zone, subject to approval by the County Executive; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the enterprise zone agreement between the County of Summit, the City of Cuyahoga Falls, SGS Tool Company and Crooked River Reality LLC/Haag Investments;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is authorized to execute an enterprise zone agreement between the County of Summit, the City of Cuyahoga Falls, SGS Tool Company and Crooked River Realty LLC/Haag Investments for investments within the Cuyahoga Falls Enterprise Zone in Council District 3. The agreement will provide an exemption on:

Real Property Tax -75% for ten (10) years.
