7 **A Resolution authorizing the County Executive to advertise for bids for two collapse search**
8 **and rescue vehicles, for an estimated total cost not to exceed \$270,000.00, for the**
9 **Executive's Department of Law, Insurance and Risk Management - Division of Public**
10 **Safety/Emergency Management Agency, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

14
15 WHEREAS, pursuant to Chapter 163 of the Codified Ordinances County of Summit
16 Special Operations Response Teams ("SORT") Executive Board was created to, among other
17 things, supervise the Technical Rescue Operations Team ("TROT") including training and
18 equipping the TROT; and

20 WHEREAS, the County Executive wishes to advertise for bids for two collapse search
21 and rescue vehicles for the SORT Executive Board to support the operations of TROT, for an
22 estimated total cost not to exceed \$270,000.00; and

24 WHEREAS, the purchase of the collapse search and rescue vehicles shall be funded by
25 Fiscal Year 2013 State Homeland Security Grant Program funds; and

27 WHEREAS, a copy of the specifications are on file in the Clerk of Council's office; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that authorizing the County Executive to advertise for bids for two collapse search and rescue
31 vehicles is necessary and in the best interest of the County of Summit;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that;

36 SECTION 1

38 The County Executive is authorized to advertise for bids for two collapse search and
39 rescue vehicles for an estimated total cost not to exceed \$270,000.00.

43 This Resolution is declared an emergency in the interest of the health, safety, and welfare
44 of the citizens of the County of Summit, and for the further reason that it authorizes the
45 Executive to immediately advertise for bids for two collapse search and rescue vehicles.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
