7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Bridgestone Americas, Inc., for utility billing services for Fiscal Year 2014, under City of**
9 **Stow contract pricing, in an amount not to exceed \$100,000.00, for the Executive's**
10 **Department of Environmental Services, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 23, 2014, awarded a purchase
13 order with Bridgestone Americas, Inc., for utility billing services for Fiscal Year 2014, under
14 City of Stow contract pricing, subject to confirmation by County Council; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase order is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with Bridgestone Americas, Inc.,
25 for utility billing services for Fiscal Year 2014, under City of Stow contract pricing, in an
26 amount not to exceed \$100,000.00, is hereby confirmed and the County Executive is hereby
27 authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide utility billing services in 2014.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
45 deliberations of this Council and of any of its committees that resulted in such formal action,
