7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Jones Stuckey for professional design services for the Vanderhoof Road**
9 **Bridge Replacement Project, in the City of New Franklin, in Council District 7, in an**
10 **amount not to exceed \$265,232.00, for the Engineer, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 23, 2014, awarded a
13 professional service contract with Jones Stuckey for professional design services for the
14 Vanderhoof Road Bridge Replacement Project (No. FRA-215-0290), in the City of New
15 Franklin, in Council District 7, subject to confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a professional service contract with Jones Stuckey
26 for professional design services for the Vanderhoof Road Bridge Replacement Project (No.
27 FRA-215-0290), in the City of New Franklin, in Council District 7, in an amount not to exceed
28 \$265,232.00, is hereby confirmed and the County Executive is hereby authorized to execute such
29 contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide for the design services for the aforementioned bridge replacement in the City of New
36 Franklin in 2014.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
