WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC"), through the Community Corrections Act ("CCA") grant program, has renewed the award to the County of Summit of a 407 grant for State Fiscal Year ("SFY") 2015, in the amount of \$1,239,107.00, with no local cash match requirement, for community corrections programs to be operated by the Summit County Adult Probation Department and Oriana House, Inc., for the period 7/1/14 through 6/30/15, and

WHEREAS, it is necessary for the County Executive to execute documents necessary to accept the grant award and to appropriate expenses; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute any documents necessary to accept the CCA 407 grant funds in the amount of \$1,239,107.00, with no local cash match requirement, for SFY 2015, and to appropriate expenses;
