12 Development has been awarded federal funds in a Home Weatherization Assistance Program  
13 ("HWAP") for program year 2013, from the U.S. Department of Energy ("DOE") and from the  
14 U.S. Department of Health and Human Services ("HHS") approved in Resolution No. 2013-346;

17 WHEREAS, adjustments of appropriations are required for HHS expenditures in order to  
18 meet state guidelines for completed units; and

8 effect and be in force at the earliest time provided by law.


