WHEREAS, the Department of Finance and Budget and the Board of Control have previously approved purchases by the County Executive in calendar year 2014 in aggregate totaling \$25,436.55 for the Department of Environmental Services with REXEL for replacement parts for pump station operations; and
WHEREAS, the Department of Environmental Services anticipates that the County Executive will make additional purchases in calendar year 2014 from REXEL for replacement parts in an additional amount not to exceed \$39,563.45, for a total aggregate amount not to exceed \$65,000.00 in calendar year 2014; and
WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to ratify purchases by the County Executive in calendar year 2014 from REXEL for replacement parts for pump station operations in the aggregate amount of \$25,436.55, and to authorize additional purchases in an amount not to exceed \$39,563.45, for a total aggregate amount not to exceed \$65,000.00, for calendar year 2014;
