A Resolution accepting the recommendations of the Tax Incentive Review Council regarding numerous enterprise zone agreements in Summit County, in Council Districts 1, 2, 3 and 7, for the Executive's Department of Community and Economic Development, and declaring an emergency.

WHEREAS, the County of Summit, with the consent of several townships and municipalities within the County, has designated certain areas within those townships and municipalities as enterprise zones, pursuant to Sections 5709.61 through 5709.69 of the Ohio Revised Code ("O.R.C."); and

WHEREAS, the purpose of said enterprise zone is to provide these townships and municipalities with an effective tool for managing and guiding economic development by enhancing the tax base by encouraging and sustaining long term investment in these communities by enhancing the quality of life, and by preserving existing business and attracting new business; and

WHEREAS, the County of Summit has previously entered into several enterprise zone agreements with various business for the abatement of portions of the business' real property and/or tangible personal property taxes as incentives for the business to invest in the communities; and

WHEREAS, O.R.C. § 5709.85 requires a county that enters into an enterprise zone agreement to appoint a Tax Incentive Review Council ("TIRC") to review each enterprise zone agreement, to review each business' compliance with each agreement and make certain recommendations to either continue, modify or terminate said agreements; and

WHEREAS, pursuant to O.R.C. § 5709.85, the Council of the County of Summit is required to either accept, reject or modify all or any portion of the recommendations of the TIRC; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to accept the recommendations of the TIRC regarding numerous enterprise zone agreements within Summit County;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
