7 **A Resolution appropriating funds totaling \$2,100,000.00 for the Summit County Children**
8 **Services Board for Fiscal Year 2016, for the Executive's Department of Finance and**
9 **Budget and the Summit County Children Services Board, and declaring an emergency.**

11 WHEREAS, over the course of the past year, the Summit County Children Services
12 Board has seen a significant increase in custody cases and paid placement costs; and

13
14 WHEREAS, at a Summit County Children Services Board meeting held on September
15 26, 2016, a motion was approved by board members to request \$2,100,000.00 be appropriated
16 for the purpose of paying placement costs through the remainder of 2016; and

18 WHEREAS, at a Social Services Advisory Board ("SSAB") meeting held on September
19 28, 2016, a motion was approved by SSAB board members to recommend the County Executive
20 submit a Resolution to County Council seeking approval of the Children Services Board's
21 request to appropriate \$2,100,000.00; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information
24 that appropriations requested by the Summit County Children Services Board totaling
25 \$2,100,000.00 are necessary and in the best interest of the County of Summit;
