7 **A Resolution adjusting existing appropriations in the amount of \$64,000.00 within the**
8 **Prosecutor's General Fund for the fiscal year ending 12/31/16, for the County of Summit**
9 **Prosecutor, and declaring an emergency.**

11 WHEREAS, this Council previously adopted Resolution No. 2015-496, which approved
12 and appropriated the 2016 operating budget for the County of Summit, which included salary
13 appropriations for the Prosecutor's General Fund for the fiscal year ending 12/31/16; and

15 WHEREAS, due to attrition and unpaid family medical leave, a surplus exists within the
16 Prosecutor's Office's salary appropriations; and

18 WHEREAS, it is necessary to adjust \$64,000.00 in current salary appropriations in order
19 to provide funding for other expenses; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the aforementioned adjustment of said existing appropriations is necessary and in the best
23 interest of the County of Summit;
