7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the State of Ohio Attorney General's Office of a Federal Fiscal**
9 **Year 2017 Victims of Crime Act grant, in the amount of \$171,175.58, with a 25% local cash**
10 **match requirement of \$42,793.89, and a Federal Fiscal Year 2017 State Victims Assistance**
11 **Act grant, in the amount of \$3,286.10, with no local cash match requirement, both for the**
12 **period of 10/1/16 through 9/30/17, and appropriating funds, for the Court of Common**
13 **Pleas- Juvenile Division, and declaring an emergency.**

15 WHEREAS, the Court of Common Pleas-Juvenile Division, has received an award from
16 the State of Ohio Attorney General's Office of a Federal Fiscal Year ("FFY") 2017 Victims of
17 Crime Act ("VOCA") grant in the amount of \$171,175.58, with a 25% local cash match
18 requirement of \$42,793.89 to be paid from the Juvenile Court General Fund administrative
19 budget, for the period 10/1/16 through 9/30/17; and

21 WHEREAS, the Court of Common Pleas-Juvenile Division has also received an award
22 from the State of Ohio Attorney General's Office of a FFY 2017 State Victims Assistance Act
23 ("SVAA") grant, in the amount of \$3,286.10, with no local cash match requirement, for the
24 period 10/1/16 through 9/30/17, and for which the State of Ohio Attorney General's Office
25 requires an accounting identity separate from the VOCA award; and

27 WHEREAS, the VOCA and SVAA are annual grants which help to support salary and
28 benefits for two volunteer coordinators and a Guardian Ad Litem, all full time, providing
29 advocacy services to crime victims in Summit County; and

31 WHEREAS, the Court of Common Pleas-Juvenile Division provides for the required
32 VOCA grant match within its annual budget; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the County
36 Executive to execute any documents necessary to accept the aforementioned grants from the
37 State of Ohio Attorney General's Office and to appropriate funds;






