A Resolution confirming an award by the Board of Control of an extension on a month-to-month basis of a professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate medical services, for a six-month period, from 1/1/17 through 6/30/17, for a total amount not to exceed \$1,021,043.40, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2010-380, which confirmed the award by the Board of Control of a professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate medical services for the period of 1/1/11 to 12/31/11, with five options to renew for a one-year period, in an amount not to exceed \$2,043,598.28, for the Sheriff; and

WHEREAS, Council previously adopted Resolution No. 2015-562, which confirmed an award by the Board of Control of a renewal (fifth and final) of the aforementioned professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate medical services for the period of 1/1/16 through 12/31/16, in a total amount not to exceed \$1,980,685.56; and

WHEREAS, the County of Summit and Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. wish to enter into an extension on a month-to-month basis of the aforementioned professional service contract for jail inmate medical services, for a six-month period, from 1/1/17 through 6/30/17, for an amount not to exceed \$170,173.90 per month, for a total amount not to exceed \$1,021,043.40; and

WHEREAS, the Board of Control, at its meeting on November 23, 2016, awarded an extension on a month-to-month basis of a professional service contract with Norman R. Johnson, M.D., aka Advanced Correctional Healthcare, Inc. for jail inmate medical services, for a sixmonth period, from 1/1/17 through 6/30/17, for an amount not to exceed \$170,173.90 per month, for a total amount not to exceed \$1,021,043.40, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned month-to-month extension of a professional service contract with Norman R. Johnson M.D., aka Advanced Correctional Healthcare, Inc. is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
