7 **A Resolution authorizing the County Executive to execute a one-year policing contract with**
8 **the County of Summit Developmental Disabilities Board, to provide two Sheriff's Deputies**
9 **and two, one-third shifts of a vehicle, for the period 1/1/17 through 12/31/17, for the**
10 **amount of \$222,766.66, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the County of Summit Developmental Disabilities Board ("DD Board") and
13 the DD Board wishes to enter into a one-year policing contract with the County of Summit to
14 provide two County Sheriff's Deputies and two one-third shifts of a vehicle, for the period 1/1/17
15 through 12/31/17; and

17 WHEREAS, the DD Board has agreed to pay the County the amount of \$18,563.89 per
18 month, for total of \$222,766.66, for the period 1/1/17 through 12/31/17, and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned policing contract is necessary and in the best interest of the County of
22 Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that;

27 SECTION 1

29 The County Executive is hereby authorized to execute a one-year policing contract with
30 the County of Summit Developmental Disabilities Board ("DD Board"), to provide two Sheriff's
31 Deputies and two one-third shifts of a vehicle, for the period 1/1/17 through 12/31/17, the
32 amount of \$18,563.89 per month, for a total amount of \$222,766.66 for the one-year term of the
33 policing contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and
38 welfare of the citizens of the County of Summit and for the further purpose of immediately
39 providing necessary policing to County of Summit Developmental Disabilities Board effective
40 1/1/17.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
