A Resolution authorizing the County Executive to execute a one-year policing contract with the County of Summit Developmental Disabilities Board, to provide two Sheriff's Deputies and two, one-third shifts of a vehicle, for the period 1/1/17 through 12/31/17, for the amount of \$222,766.66, for the Sheriff, and declaring an emergency.

WHEREAS, the County of Summit Developmental Disabilities Board ("DD Board") and the DD Board wishes to enter into a one-year policing contract with the County of Summit to provide two County Sheriff's Deputies and two one-third shifts of a vehicle, for the period 1/1/17 through 12/31/17; and

WHEREAS, the DD Board has agreed to pay the County the amount of \$18,563.89 per month, for total of \$222,766.66, for the period 1/1/17 through 12/31/17, and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned policing contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to execute a one-year policing contract with the County of Summit Developmental Disabilities Board ("DD Board"), to provide two Sheriff's Deputies and two one-third shifts of a vehicle, for the period 1/1/17 through 12/31/17, the amount of \$18,563.89 per month, for a total amount of \$222,766.66 for the one-year term of the policing contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further purpose of immediately providing necessary policing to County of Summit Developmental Disabilities Board effective 1/1/17.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
