7 **A Resolution authorizing the County Executive to execute an intergovernmental**
8 **agreement with the Summit County Combined General Health District d.b.a. Summit**
9 **County Public Health pursuant to which the County Sheriff's Office will transport**
10 **unused pharmaceuticals for incineration, for payment by Summit County Public Health**
11 **in the amount of \$50.00 per hour, for a total amount not to exceed \$14,400.00 per year,**
12 **for the Sheriff, and declaring an emergency.**

14 WHEREAS, the County Sheriff is responsible for delivering collected pharmaceuticals
15 to the Ross Environmental Services incinerator facility in Elyria, Ohio as part of the Summit
16 County pharmaceutical disposed unused medical prescription program ("D.U.M.P. program");
17 and

19 WHEREAS, the Summit County Combined General Health District d.b.a. Summit
20 County Public Health has agreed to pay the Sheriff \$50.00 per hour to transport said unused
21 pharmaceuticals, for a total amount not to exceed \$14,400.00 per year; and

23 WHEREAS, it is necessary for the County and Summit County Public Health to enter
24 into an intergovernmental agreement to set forth the duties and responsibilities of the parties
25 concerning the transport of unused pharmaceuticals related to the D.U.M.P. program; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent
28 information, that it is necessary and in the best interest of the County of Summit to authorize
29 the County Executive to execute said intergovernmental agreement with Summit County Public
30 Health for the aforementioned reason;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,
33 State of Ohio, that:

35 SECTION 1

37 The County Executive is hereby authorized to execute an intergovernmental agreement
38 with the Summit County Combined General Health District d.b.a. Summit County Public
39 Health pursuant to which the County Sheriff's Office will transport unused pharmaceuticals to
40 the Ross Environmental Services incinerator facility in Elyria, Ohio as part of the Summit
41 County pharmaceutical disposed unused medical prescription program ("D.U.M.P. program"),
42 for payment by Summit County Public Health to the Sheriff in the amount of \$50.00 per hour,
43 for a total amount not to exceed \$14,400.00 per year. The Executive is hereby authorized to
44 execute said intergovernmental agreement with the Summit County Combined General Health
45 District d.b.a. Summit County Public Health in substantially the form attached hereto as Exhibit
46 A.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and
51 welfare of the citizens of the County of Summit, and for the further reason to immediately
52 authorize the Executive to execute a necessary intergovernmental agreement with Summit
53 County Public Health pursuant to which the Sheriff's Office will transport unused
54 pharmaceuticals for incineration as part of the D.U.M.P. program.
