A Resolution authorizing the County Executive, pursuant to Section 177.17 of the Codified Ordinances of the County of Summit, to solicit offers for the lease of space in the County of Summit Courthouse for the purpose of food service operations, for the Executive's Department of Administrative Services, and declaring an emergency.

COMMITTEE Planning

WHEREAS, Section 177.17 of the Codified Ordinances of the County of Summit provides that upon the determination of the Executive that any real property, including land, buildings, public improvements or other improvements or any part thereof, owned by the County is not necessary for County operations, the Executive shall submit to Council a proposed resolution authorizing the Executive to solicit offers for the lease of the real property or any part thereof, and to negotiate terms and conditions with any person or entity that submits an offer to lease; and

WHEREAS, County Council previously adopted Resolution No. 2016-035, which authorized the County Executive to execute a five-year lease with Hattie Larlham Community Services for approximately 1,075 square feet of space in the County of Summit Courthouse, located at 209 South High Street, Akron, Ohio 44308, in Council District 4, for the purpose of food service operations, from 1/1/16 through 12/31/20, for rent of \$1.00 per year; and

WHEREAS, said lease was executed with Hattie Larlham Community Services; and

WHEREAS, Hattie Larlham Community Services has terminated the lease and is no longer providing food services; and

WHEREAS, the County Executive wishes to solicit offers for the lease of space in the County of Summit Courthouse for the purpose of food service operations and to negotiate terms and conditions with persons or entities submitting an offer to lease said space for such purpose; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to solicit offers for the lease of space in the County of Summit Courthouse for the purpose of food service operations and to negotiate terms and conditions with persons or entities submitting an offer to lease said space for such purpose;
