8 **A Resolution establishing the compensation of the County of Summit Human Resource**
9 **Commission members at an annual salary of \$8,190.00, with no fringe benefits, other than**
10 **the Ohio Public Employees Retirement System, effective 12/26/16, to be paid in 26 equal**
11 **payments, for the Executive, and declaring an emergency.**

13 WHEREAS, pursuant to the Article VI, Section 6.01 of the County of Summit Charter,
14 County Council is authorized to review and establish the compensation for the members of the
15 Human Resource Commission ("HRC"); and

16
17 WHEREAS, under Ohio law, the threshold for full participation in the Ohio Public
18 Employees Retirement System by HRC members has been increased, necessitating a
19 corresponding increase in their annual salary from \$7,800.00, which was set by Resolution No.
20 2012-428, to \$8,190.00; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the compensation for HRC members should be established at an annual salary of \$8,190.00,
24 with no fringe benefits, other than the Ohio Public Employees Retirement System, effective
25 12/26/16, to be paid in 26 equal payments, for the aforementioned reason;

27 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
28 State of Ohio, that:

30 SECTION 1

32 Each member of the County of Summit Human Resource Commission ("HRC") shall be
33 compensated at an annual salary of \$8,190.00, with no fringe benefits, other than the Ohio Public
34 Employees Retirement System ("OPERS"), effective 12/26/16, to be paid in 26 equal payments.
35 Upon the effective date of this Resolution, the County Fiscal Officer is hereby authorized to
36 make any necessary retroactive payments to the credit of the HRC members in order for their
37 compensation to be \$8,190.00 effective 12/26/16 so they may fully participate in OPERS in
38 2017.

40 SECTION 2

42 This Resolution is hereby declared to be an emergency in the interest of the health,
43 safety, and welfare of the citizens of the County of Summit, and for the further reason to
44 immediately establish fair compensation, effective 12/26/16, for the HRC members so that they
45 may fully participate in OPERS in 2017.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.
