7 **A Resolution appropriating additional funds, in the amount of \$1,047,234.05, for the State**
8 **Fiscal Year 2017 RECLAIM Ohio Grant, for the period 7/1/16 to 6/30/17, for a total grant**
9 **award in the amount of \$5,757,595.75, with no local cash match requirement, for the Court**
10 **of Common Pleas-Juvenile Division, and declaring an emergency.**

12 WHEREAS, RECLAIM Ohio is an initiative developed in 1993 to address the State's
13 overburdened juvenile justice system and allows local courts to target specific areas to divert
14 youth from being institutionalized; and

15
16 WHEREAS, County Council previously Resolution No. 2016-238, which authorized the
17 County Executive to execute any documents necessary to accept the award by the Ohio
18 Department of Youth Services to the Court of Common Pleas-Juvenile Division of a State Fiscal
19 Year 2017 RECLAIM Ohio Grant, for the period 7/1/16 to 6/30/17, in the estimated amount of
20 \$4,710,361.70, with no local cash match requirement, and appropriated said grant funds; and

22 WHEREAS, the State Fiscal Year 2017 RECLAIM Ohio Grant award and budget for the
23 Juvenile Division has been finalized and approved in the amount of \$5,757,595.75 and it is
24 necessary to appropriate the additional \$1,047,234.05 in grant funds;

26 WHEREAS, this Council finds and determines after reviewing all pertinent information
27 that it is necessary and in the best interest of the County of Summit to authorize the County
28 Executive to execute any documents necessary to appropriate additional funds, in the amount of
29 \$1,047,234.05 in additional funds for the State Fiscal Year 2017 RECLAIM Ohio Grant, for the
30 period 7/1/16 to 6/30/17, for a total grant award in the amount of \$5,757,595.75, with no local
31 cash match requirement;

20 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
21 effect and be in force at the earliest time provided by law.

29 121.22 of the Ohio Revised Code.


