7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Best Commercial Energy Services, Inc., for the Children Services Training Center HVAC**
9 **Replacement Project, in an amount not to exceed \$84,900.00, for the Executive's**
10 **Department of Administrative Services-Physical Plants, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 12, 2017, awarded a
13 construction contract with Best Commercial Energy Services, Inc., for the Children Services
14 Training Center HVAC Replacement Project, located at 264 S. Arlington St., Akron, Ohio
15 44308, in Council District 4, in an amount not to exceed \$84,900.00, subject to confirmation by
16 County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned construction contract with Best Commercial Energy Services, Inc. is
20 necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by the Board of Control of a construction contract with Best Commercial
28 Energy Services, Inc., for the Children Services Training Center HVAC Replacement Project
29 (the "Project"), located at 264 S. Arlington St., Akron, Ohio 44308, in Council District 4, in an
30 amount not to exceed \$84,900.00, is hereby confirmed and the County Executive is hereby
31 authorized to execute such construction contract and any necessary related documents.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 confirm the award of the aforementioned construction contract in order to immediately begin
38 work on the aforementioned Project.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,
