7 **A Resolution authorizing the County Executive to execute inter-county adjustment**  
8 **agreements and any other documents necessary for the acceptance by the County**  
9 **Executive's Department of Job and Family Services of inter-county transfers of surplus**  
10 **funds from other Ohio counties, for the period 6/14/17 through 6/30/19, and assigning the**  
11 **Executive as designee of the County for said purposes for said time period, for the**  
12 **Executive's Department of Job and Family Services, and declaring an emergency.**

13  
14 WHEREAS, Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to  
15 execute a JFS 02719 "Inter-county Agreement and Certification Release and Acceptance of  
16 Funds" to engage in inter-county transfers of surplus funds allocated to county departments of  
17 job and family services by the Ohio Department of Job and Family Services; and

18  
19 WHEREAS, Section 5101:9-6-82(F)(2)(b) provides that a board of county  
20 commissioners may assign authority to another party to serve as designee and therefore, grant  
21 that party authority to sign an inter-county adjustment agreement on behalf of the county for a  
22 specific period of time; and

24 WHEREAS, the County Executive wishes to be authorized to execute the JFS 02719  
25 Inter-county Agreement and Certification Release and Acceptance of Funds, and any other  
26 documents necessary pursuant to Section 5101:9-6-82 for the acceptance by the County  
27 Executive's Department of Job and Family Services ("SCDJFS") of inter-county transfers of  
28 surplus funds from other Ohio counties, for the period 6/14/17 through 6/30/19, and to be  
29 assigned as designee of the County for said purposes pursuant to Section 5101:9-6-82(F)(2)(b)  
30 for said time period; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
34 execute the JFS 02719 Inter-county Agreement and Certification Release and Acceptance of  
35 Funds, and any other documents necessary pursuant to Section 5101:9-6-82 for the acceptance  
36 by SCDJFS of inter-county transfers of surplus funds from other Ohio counties, for the period  
37 6/14/17 through 6/30/19, and to be assigned as designee of the County for said purposes pursuant  
38 to Section 5101:9-6-82(F)(2)(b) for said time period;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
41 of Ohio, that:

45 The County Executive is hereby authorized to execute the JFS 02719 Inter-county  
46 Agreement and Certification Release and Acceptance of Funds, and any other documents  
47 necessary pursuant to Section 5101:9-6-82 for the acceptance by the County Executive's  
48 Department of Job and Family Services ("SCDJFS") of inter-county transfers of surplus funds  
49 from other Ohio counties, for the period 6/14/17 through 6/30/19. The Executive is hereby  
50 assigned as designee of the County of Summit to execute said agreements and documents as  
51 provided in Section 5101:9-6-82(F)(2)(b), for the period 6/14/17 through 6/30/19.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the citizens of the County of Summit and for the further reason to immediately  
8 authorize the Executive to execute agreements and documents necessary for SCDJFS to accept  
9 inter-county transfers of surplus funds from other Ohio counties effective 6/14/17.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take  
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all

23 121.22 of the Ohio Revised Code.


