11 non-bargaining part-time employee Adriana Blasio effective June 26, 2017; and

13 WHEREAS, because the salary adjustment for the aforementioned employee represents a
14 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, County
15 Council's approval is required; and

17 WHEREAS, the Director of the County Executive's Department of Human Resources
18 will review the personnel action for the aforementioned salary adjustment as required by Section
19 169.07(b) of the Codified Ordinances; and

21 WHEREAS, the salary adjustment will be submitted to the Director of the Executive's
22 Department of Finance and Budget for the certification of availability of sufficient appropriated
23 funds for the adjustment, as required by Section 169.07(c) of the Codified Ordinances; and

25 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
26 is necessary and in the best interest of the County of Summit to approve and authorize the
27 Prosecutor to make the aforementioned salary adjustment effective June 26, 2017;
