8 **AdvizeX Technologies LLC, at State Term Pricing, for information technology**
9 **infrastructure updates at the OhioMeansJobs Summit County Center, located in the City**
10 **of Akron, in Council District 2, in an amount not to exceed \$149,469.55, for the Office of**
11 **Information Technology and Executive's Department of Job and Family Services, and**

14 WHEREAS, the Board of Control, at its meeting held May 17, 2017, awarded a purchase
15 contract with AdvizeX Technologies LLC, at State Term Pricing, for information technology
16 infrastructure updates at the OhioMeansJobs Summit County Center, located in the City of
17 Akron, in Council District 2, approved by the IT Board 3/2/2017, in an amount not to exceed
18 \$149,469.55, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned purchase contract with AdvizeX Technologies LLC is necessary and in
22 the best interest of the County of Summit;

29 The award by the Board of Control of a purchase contract with AdvizeX Technologies
30 LLC, at State Term Pricing, for infrastructure updates at the OhioMeansJobs Summit County
31 Center, located in the City of Akron, in Council District 2, approved by the IT Board 3/2/2017,
32 in an amount not to exceed \$149,469.55, is hereby confirmed and the County Executive is
33 hereby authorized to execute such purchase contract and any related necessary documents.


