8 **contract with United Labor Agency, for specific career services self-directed employment**
9 **services, and coordination of one-stop job services at the OhioMeansJobs Summit County**
10 **Center, located in the City of Akron, in Council District 2, for the period of 7/1/17 through**
11 **9/30/18, in an amount not to exceed \$225,000.00, for the Executive's Department of Job and**
12 **Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held May 31, 2017, awarded a
15 professional service contract with United Labor Agency, for specific career services self-directed
16 employment services, and coordination of one-stop job services at the OhioMeansJobs Summit
17 County Center, located in the City of Akron, in Council District 2, for the period of 7/1/17
18 through 9/30/18, in an amount not to exceed \$225,000.00; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that the aforementioned professional service contract with United Labor Agency is necessary and
22 in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The award by the Board of Control of a professional service contract with United Labor
30 Agency, for specific career services self-directed employment services, and coordination of one-
31 stop job services at the OhioMeansJobs Summit County Center, located in the City of Akron, in
32 Council District 2, for the period of 7/1/17 through 9/30/18, in an amount not to exceed
33 \$225,000.00, is hereby confirmed, and the County Executive is authorized to execute said
34 professional service contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the citizens of the County of Summit, and for the further reason that the
40 aforementioned professional service contract with United Labor Agency is immediately
41 necessary to provide the aforementioned services effective 7/1/17.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.


